A Unique Attraction in the Heart of the Village

The West Lancashire Light Railway has been a unique feature in the village of Hesketh Bank for over 50 Years, operating a heritage steam narrow gauge railway for families and railway enthusiasts, while providing education through demonstration and display of the now disappeared industrial narrow gauge railway.

The West Lancashire Light Railway Trust is a Volunteer organisation, providing meaningful and enjoyable activities for our members, both young and old, while maintaining and preserving past heritage skills.

Recent developments on the old Alty's brickwork site have sadly placed the future of the Railway at risk, with the majority of the site being sold for development.

To secure the Railway, the Trust has agreed to purchase their existing site for £250,000. – a large sum for a small organisation. Whilst we have been successful in securing funding in the short term from members and friends of the Railway, a significant part of these funds is through loans. These have to be repaid.

We are therefore asking our all our Members and Friends to help us meet the funding shortfall with a monthly donation of £10 per month for 5 years. A cup of coffee a week! This will assist us to repay the loans and help fund critical capital investment for a new entrance and visitor facilities at our Becconsall Station.

We need a minimum of 160 subscriptions. We would also welcome multi-subscriptions and/or donations. Whatever you can give will be very gratefully received. Both one-off and monthly donations can be Gift Aided if you are a full UK tax payer, providing us with a whopping 25% addition to your contribution.
